To read and confirm the minutes of fifteenth (15th) meeting of Academic Council held on 19th October, 2022.

Resolution: The MoM of fifteenth (15th) meeting of Academic Council was shared with all members in online mode. The minutes of 15th AC was read by Dean Academics and confirmed in the meeting.

Item No 2:

To discuss and approve the revised curriculum structure as per guidelines of NEP and its effective implementation from A.Y. 2023-24 of all the B. Tech. Programs as approved by the respective Board of Studies (BoS) in the following sequence:

- 1. Curriculum Structure for First Year B. Tech.
- 2. Curriculum Structure for B. Tech. (Civil Engineering)
- 3. Curriculum Structure for B. Tech. (Computer Engineering)
- 4. Curriculum Structure for B. Tech. (Electrical Engineering)
- 5. Curriculum Structure for B. Tech. (Electronics and Telecommunication Engineering)
- 6. Curriculum Structure for B. Tech. (Instrumentation Engineering)
- 7. Curriculum Structure for B. Tech. (Mechanical Engineering)

Resolution: Undergraduate structure for all six programs mentioned above were presented by respective Board of Studies (BoS) as per NEP 2020 guidelines and GR issued by Govt. of Maharashtra dated 4th July 2023. It is resolved to keep 172 credits for B.Tech. in Engg./Tech. with multidisciplinary minor. Earlier revision of the curriculum was implemented in AY 2022-23 for first year. As per the guidelines of NEP 2020 curriculum is revised from AY 2023-24 in a phased manner. After several discussion and approval in respective Departmental Faculty Board (DFB) and Board of Studies (BoS), Academic Program Evaluation Committee(APEC) the revised curriculum structure of respective program from I to IV year was presented and discussed in the EC meeting. After discussion and deliberation AC approved the revised curriculum structure (wef AY 2023-24) of I to IV year structure of six (06) B.Tech. Program.

Item No. 3:

To discuss and approve the revised syllabus of theory and lab courses for First Year B. Tech. as per guidelines of NEP and its effective implementation from A.Y. 2023-24, as approved by the respective Board of Studies (BoS)

Resolution: It was discussed in respective Board of Studies (BoS) and approved by APEC. It was noted and approved by AC.

Item No 4:

To discuss and decide about the proposal for reducing the number of Mid semester Examinations (MSE), End Semester Examinations (ESEs) in an academic year. To discuss, revise and approve R15.2 - Cancel repeat MSE, R15.4- Cancel Re- ESE, Revise R 15.5- Total marks should be 40% in (ISA, MSE and ESE) in respective course. Also, cancel Make up examination. Instead of Re MSE and Re ESE at the end of even semester Re-ESE for odd and even course can be conducted.

Resolution: AC resolved that decision taken in Examination committee meeting on 13-07-2023 will be retained.

To discuss and approve: Grace marks facility only for two failed courses and condonation marks

facility only for one failed course.

To discuss and approve Academic Calendar 2023-24.

For the convenience of MIS software implementation, 2018-19 course codes will be used by replacing "U" with "R" and syllabus will be same as 2018-19 structure.
