

All the members were of the opinion that; curriculum structure shall be revised and new structure shall be based on "Choice Based Credit System (CBCS)" and shall follow the guidelines issued by National Knowledge Commission (NKC) and model curriculum published by All India Council for Technical Education (AICTE). Innovative practices and courses like Multidisciplinary Project (MDP), MOOCs, and courses of SWAYAM etc shall be included in curriculum to enhance employability of students. In addition; curriculum shall focus more on practical in response to criticism from practicing engineers that "Engineering education in India is too theoretical and analytical in nature". Evaluation system may also be reformed if possible.
