At the start of the meeting, Dr V R Saraf, welcomed all members of Board of Studies in Civil Engineering. Dr R P Borkar, Dr S B Duggad, Dr. Ratnakar Mahajan and Ms Shrutakirti Mahajan had expressed their inability to attend the meeting due to some unavoidable circumstances, and therefore leave of absence was granted to them. The meeting discussion was started with item wise and noted.

### Item No 1:

To read and confirm the minutes of eighth meeting of BoS, Civil Engineering held in Civil Engineering Department on **30<sup>th</sup> August 2017**

The minutes of eighth BoS meeting held on 30<sup>th</sup> August 2017 was discussed and confirmed by all the members unanimously.

### Item No 2:

To note and approve the action taken by department on the agenda points discussed and resolved in the eighth meeting of BoS.

Changes suggested by BoS members in syllabus were carried out and the revised syllabus was approved by academic council.

### Item No 3:

To discuss and approve new curriculum structure and detailed syllabus of first year UG Program of Engineering Mechanics.

The curriculum of BTech courses was to be revised in view of AICTE model curriculum. The department framed a curriculum structure and curriculum of first year. After discussion in BoS meeting, following suggestion need to be incorporated in new curriculum structures

- Subject of humanities and basic engineering should be distributed as one course per semester
- Professional elective shall consist of at least 7 courses.
- Open elective list should be enhance as per the availability from other department.
- In professional elective Finite Element Method, Advanced Design of Steel Structures, Advance R.C.C., Structural dynamics and few other courses to be added..

### In Engineering Mechanics Syllabus

- Engineering Mechanics syllabus should be reframed for Kinetics, Kinematics and Mechanical vibration. Only introduction of these topics shall be covered and some portion of plain strain, plain stress etc. may be added

- BoS authorized chairman to do respective changes in structure and curriculum

institute.

**Item No 4:**

To discuss on the current examination system

BoS discussed current examination system with respect to student point of view and institute point of view

- Dr Ingle suggested that the present system consist of too much examination which may not gives expected results.
- Dr Regulwar commented that current semester examination shall be conducted only current semester offered courses and no backlog shall be examined during current semester.

After discussion on various issue, BoS (Civil) suggested for new examination system to be implemented by the institute from next academic year as below

- Only current offered courses examination shall be conducted during summer and winter examination
- After every end semester examination only one re-examination shall be conducted one month after the result.
- Students may allow to appear for current courses as backlog if any without appearing for ISE and ISA.

**Item No 5:**

Any other point by the permission of chair.


A) Approval for Summer and Winter 2018 panel of evaluators and paper setter.

- BoS chairman has recommended Summer 2018 panel for paper setter and evaluators in anticipation of the approval from BoS. Now BoS had given post facto approval for the panel of paper setter and evaluators of Summer 2018 examination.
- BoS also approved panel of examiners for Winter 2018 examination. BoS authorized Chairman to revised the panel if required


B) Approval to PO, PSO and COs of BTech Civil Engineering.

- BoS discussed PO, PSO and Cos of BTech Civil Engineering and approved the same.
