At the start of the meeting, Smt. D. P. Yavalkar, COE welcomed all Honourable members of EC Committee.

Dr. S. S. Gajre, Principal welcomes Dr. D. S. Dalal sir.

With the permission of chairman, the proceeding started.

Item Details are as follows:

Item No. 01:

To read and confirm the minutes of the fifteenth meeting of the Examination Committee of the institute which was held on July 13, 2023.

All the EC members requested to go through the MOM and suggest changes if any.

Decision: -Minutes of fifteenth meeting of the Examination Committee of institute has been read and confirmed.

Item No. 02:

Rule No. 3.2: To cancel Repeat MSE and Make up Exam for TH-ESE.

Decision: - After a thorough discussion, the committee decided to cancel the Repeat MSE and Make up exam for TH-ESE.

Item No. 03:

To revise the pattern of TH-ESE and PR-ESE for winter and summer (regular and re-exams).

Decision:- The committee decided that the winter exam will be for odd semester and summer exam will be for even semester and Re-Exam of both the semester will be held together for odd and even semester after summer 2024 regular exams.

Item No. 04:

To revise the time duration of MSE (1.5 Hrs.), TH-ESE (2.5 Hrs.).

Decision: - The committee decided to revise the time duration of MSE (1.5Hr.), and time duration of TH-ESE shall be kept as it is (3/4 Hours).

Item No. 05:

To revise the rule for internal choice for MSE and TH-ESE.

Decision:- The committee decided that the internal choice shall be given but maximum 30% choice shall be removed for MSE and TH-ESE and paper can be set with internal choice as many as paper setter wants.

Item No. 06:

To revise the rule for paper setting and moderation of question paper.

Decision:- The committee decided that the Paper setting should be given only to the course teacher and moderation of question paper will be done by the BoS, chairman for all courses of the concern course to which the course belongs.

Item No. 07:

To dissolve the Grade Moderation Committee.

Decision:- The committee decided not to dissolve the Grade Moderation Committee.

Item No. 08:

To revise the punishment rules for copy cases.

Decision:- The committee decided that the nomenclature of the various posts/committee shall be revised if required). But, punishments rules shall be kept as it is.

Item No. 09:

To grant post facto permission for additional exams held for odd sem (for I to IV sem for TH-ESE) and free Open House Revaluation for all the appearing students (Re-exam summer - 23).

Decision:- The committee decided give approval for the additional exam which was held for I to IV sem of those students who were likely to detained for academic year 2023-24.

Item No. 10:

To grant post facto permission for paid Open House Revaluation for TH-ESE exams and fees worth Rs. 300/- for winter - 23 exams.

Decision:- The committee decided give the approval for open house for re-exam FY-SY-Summer-2023 for free and paid open house worth Rs. 300/- for Winter-2023 regular exam. Committee approves the fees for paid open house for all the exams conducted thereafter.

Item No. 11:

To revise the remuneration of different faculties working in AEC and in the Examination cell.

Decision:- The committee decided to form a committee and take a review of cash inflow and outflow and take the decision accordingly.

Item No. 12:

Any other business with kind permission of the Chairman.

Decision: - 1. NPTEL policy was approved by EC.


UGC has already issued the UGC (Credit Framework for online learning courses through SWAYAM) Regulation 2016 advising the Universities to identify courses where credits can be transferred on to the academic record of the students for courses done on SWAYAM. AICTE has also put out gazette notification in 2016 and subsequently for adoption of these courses for credit transfer.

Following policy has been resolved in the HoD meeting, for the credit transfer of NPTEL courses in Summer-2024 semester.

- a. All the students who enrol and register for SWAYAM-NPTEL [Study Webs of Active Learning for Young Aspiring Minds- National Program for Technology Enhanced Learning] course are eligible for credit transfer provided the course is approved by respective BoS(Chairman)
- b. Students need to complete the course registration in MIS for the respective NPTEL course during course registration for Summer-2024 and get it approved by the class teacher.
- c. NPTEL enrolment fee will be reimbursed to the students who PASS the NPTEL course with certificate type Successfully completed/Elite/Elite+Silver/Elite+Gold
- d. The marks secured in the NPTEL course are converted by the concerned course mentor/ coordinator such that the highest securing student should get A+ grade as per institute grading system mentioned in Autonomy rules. Accordingly, other students' marks will also be updated.
- e. The final mark list of the students will be sent by the concerned course mentor/ coordinator to Academic and Examination Cell for entry into MIS.
- f. In case of no certification/FAIL in NPTEL examination, students will be eligible to appear for Summer-2024 examination of equivalent course approved in BoS and EC and AC. Concern BoS, Chairman shall convey the name and code of that course to AEC, so that the exam will be conducted for those students. To pass the course, students need to score 24 marks [40%] out of 60 in the TH-ESE Summer-2024 examination of equivalent course. The marks secured out of 60 will be converted to out of 100 for entry in MIS.
- g. The course coordinator is authorised to decide the mark range for those option – II students.

2. The Committee decided that the Chairman of EC reserves the right to make minor changes for smooth conduction of exams and take the decision in favour of the students to avoid their academic loss.
