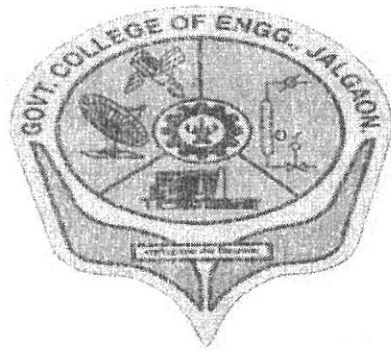

Item No 1:

To read and confirm the minutes of thirteenth (13th) meeting of Academic Council held in the online mode.

The MoM of thirteenth (13th) meeting were already shared with all members. It was again shared in online mode and read. The MoM of the earlier (13th) meeting was confirmed by the AC.

Item No 2:

To note and approve the action taken by the institute on the agenda points discussed and resolved in the earlier meeting of Academic Council.

The Action Taken Report on the basis of MoM of AC-13 was shared and read in online mode. It was approved by AC.

Item No. 3:

To discuss and approve the student promotion policy (carry-forward) implemented by this institute (AY 2020-21 to AY 2021-22), in view of COVID-19 situation.

In view of continued COVID-19 situation and online teaching, a decision of carry-forward of all students except final year students was taken by the KBC North Maharashtra University and a circular was issued to all the affiliated colleges for its implementation. Accordingly, this institute has also decided to implement the carry-forward in a meeting of HoDs and Deans with Hon. Principal (Chairman, AC). A circular was issued in this regard.

“All the students (except final year students) from A.Y. 2020-21 shall be promoted to the next class in A.Y. 2021-22 and their backlog courses will be carried-forward.”

Dean (Academics) elaborated the point to Hon. AC members and AC approved this agenda point.

Item No. 4:

To consider the applications of extension of one year for completing the degree program (in view of their certain circumstances and also in view of COVID-19 situation) and grant the approval of AC.

2. Sachin Vinodrao Dahake, Civil Engineering, PRN: 1551009 (Reason: His mental and physical health) (No Documents Attached)
3. Kiran Sheshrao More, Electrical Engineering, PRN: 1531037 (Reason: Death of his father)
4. Viral Rupsing Nole, Instrumentation Engineering, PRN: 1521032 (Reason: His Own health problems, death of his grandfather, Mother's health)

In view of the deteriorated mental and physical health of the students and also, in view of COVID-19 situation, lockdown and technical problems in online education, the Hon. AC granted the approval for extension of one year for completing the B. Tech. degree for these 4 students.

Item No 5

To discuss and decide about the proposal for increasing the number of years allowed to complete the B. Tech. Degree program -

- from 6 years to 7 years for regular FY admitted students
- from 5 years to 6 years for Direct Second Year admitted students

(Modification proposed in Autonomy Rule R 2.2)

Every year, around 4 to 5 students cannot complete their B. Tech. degree programs in stipulated period and submit a request for extension of one more year for completing their B. Tech. Degree program and considering the circumstances, the extension is generally granted, in order to avoid the academic loss of the students. In view of this, the limit for completing the B. Tech. degree program is increased in the rules itself by one year and thereafter the provision of extension by one year under special circumstances is approved by AC.

The Hon. AC members discussed the proposal and provided the approval for this agenda item.

This modification in Autonomy Rule R2.2 will be applicable for all students completing the B. Tech. degree program in A. Y. 2022-23 onwards.

Item No. 6

To discuss and approve the revised Academic Calendar for the A. Y. 2021-22 for SY (and Direct Second Year), TY, Final Year and also for First Year Engineering.

Revised Academic Calendar 2021-22 of SY, TY, Final Year and also First Year Academic Calendar 2021-22 was shared in the online meeting and AC approved the same.

Item No. 7

To discuss and approve the Academic Calendar for the A. Y. 2022-23 for SY, TY, Final Year.

The Academic Calendar for the A. Y. 2022-23 for III-IV year and also II year was shared with all. AC discussed and approved the same.

Item No 8

To apprise the Hon. AC regarding the count of graduating students for the award of B. Tech. degree in A.Y. 2020-21 and A. Y. 2021-22 (till Summer-2022 Regular Examination) and grant the approval for the same.

The count of graduating students for the award of B. Tech. degree in A.Y. 2020-21 and A. Y. 2021-22 (till Summer-2022 Regular Examination) was shared with all. AC granted the approval for the same.

Item No 9

To approve the revised composition of BoS of Instrumentation Engineering, including the new chairman and member-secretary of this BoS.

The revised composition of BoS of Instrumentation Engineering, including the new chairman and member-secretary of this BoS, was shared with all the AC members. AC approved the same.

Item No 10

To discuss and decide about the proposal for reduction of minimum requirement of number of audit points for co-curricular and extra-curricular activities from 12 each to 8 each for the award of B. Tech. Degree, from 9 each to 6 each for direct second year admitted students and from 12 to 8 for co-curricular activities for PG programs.

(Modification proposed in Autonomy Rule R 7.1 and R 7.2)

- It is a general experience that students find it sometimes difficult to complete required minimum number of audit points for Co-curricular and Extra-curricular activities during their UG and PG degree program. In such situation, they are not held eligible for the award of the degree, even though they have passed all the courses as per the curriculum, until they earn the minimum audit points required.
- In view of this, the Hon. AC approved the proposal for reduction of minimum requirement of number of audit points for co-curricular and extra-curricular activities from 12 each to 8 each for the award of B. Tech. Degree, from 9 each to 6 each for direct second year admitted students and from 12 to 8 for co-curricular activities for PG programs. (PG students don't require the audit points for extra-curricular activities).
Also, there was a suggestion that the number of audit points required in the existing rule may be stated as 'Desirable' and the reduced number of audit points with this modification be stated as 'Essential'. This suggestion was accepted in the meeting.

This modification in Autonomy Rules will be applicable for all students of the institute completing the B. Tech. or M. Tech. degree program in A. Y. 2022-23 onwards.

Item No 11

To discuss and decide about the proposal for reducing the number of End Semester Examinations (ESEs) in an academic year from 5 ESEs to 4 ESEs from the academic year 2022-23 (implying no complementary examination)

(Modification proposed in Autonomy Rule R 15.4)

Currently, in an academic year, 5 End Semester Examinations (ESEs) are held viz. Winter, Re-exam-Winter, Summer, Re-exam-Summer, and Complementary exam.

Two Winter session exams are conducted for odd semester courses only.

Two Summer session exams are conducted for even semester courses only.

One Complementary exam is conducted for odd and even semester theory courses only, at the end of the academic year.

These 5 ESEs consume a lot of time and efforts of the faculty and also, it impacts the academic

time available in the academic calendar. Also, the FY and DSY academic and examination calendar is now a separate calendar, from SY, TY and Final year, due to late admissions almost in October/November, the number of effective ESEs are almost 10 to 12, in an academic year.

In view of the above points, the Hon. AC granted its approval for the proposal to conduct only 4 ESEs in an academic year viz.

Winter and Re-exam-Winter --- for odd semester courses only

Summer and Re-exam Summer --- for even semester courses only

This modification in Autonomy Rules will be applicable for all students of the institute studying in any year of study of the B. Tech. / M. Tech. program in the institute in A. Y. 2022-23 onwards.

Item No 12

To discuss and decide about the proposal for reducing the minimum passing marks in ESE from existing 1/3rd (33.33%) marks to 30% marks (i.e. from 20 marks to 18 marks).

(Modification Proposed in Autonomy Rule R 15.5)

It is observed that many students are in the range of 18-19 marks in ESE, as a result of which they fail in that course, even though they achieve a mark of 40 % overall marks. To provide the students with some relief, AC granted approval to this proposal.

This modification in Autonomy Rules will be applicable for all students of the institute studying in any year of study of the B. Tech. / M. Tech. program in the institute in A. Y. 2022-23 onwards.

Item No. 13

To discuss and decide about the proposal for moderation of question-papers domain-wise in each department instead of all the question-papers being moderated by the HoD.

The reasoning behind this proposal is that the HoD is not an expert in all the domains of that discipline, due to which some questions, which may be out of syllabus (and other types of mistakes by the paper-setter), may go undetected. In view of this, if domain-wise groups of the departmental faculty are formed and a group of courses assigned to that domain, the senior member of that domain group can carry out the moderation.

The AC discussed the issue on the basis of above reasoning and granted its approval for the same. This additional Examination Rule will be applicable with effect from A. Y. 2022-23 onwards.

Item No. 14

To discuss and decide about the proposal for paper-setting by the regular teachers of the course he/she is teaching (Minimum 2 sets of question-papers).

It is observed, in general, that the question-paper is sometimes beyond the scope of the syllabus of that course. The students are the ultimate sufferers in such cases.

In order to prevent this, the AC approved the proposal that paper-setting should be done by the regular teachers of the course he/she is teaching (Minimum 2 sets of question-papers to be submitted by the regular faculty). In case of visiting faculty teaching that course, if the HoD

recommends his/her name for paper-setting of that course, that visiting faculty should submit the 2 sets of question-paper of the course he/she is teaching.

This additional Examination Rule will be applicable with effect from A. Y. 2022-23 onwards.

Item No. 15

To discuss and decide about the proposal of conducting a Repeat Mid-Semester Examination (Repeat-MSE) for the students securing less than $1/3^{\text{rd}}$ marks in regular MSE (i.e. less than 10 marks out of 30)

AC discussed the proposal and the reasoning behind it. The proposal finally accepted is -

It is decided to conduct a Repeat Mid-Semester Examination (Repeat-MSE) for the students securing less than $1/3^{\text{rd}}$ marks in regular MSE (i.e. less than 10 marks out of 30). This provision will be useful for those students who, for some reason, cannot perform well in regular MSE and secure less than 10 marks out of 30 in regular MSE and want to improve their performance at MSE. Also, this repeat-MSE will be optional for those eligible students. The best of the two scores (viz. between the scores secured at regular MSE and repeat MSE) will be considered.

(This provision was approved due to the fact that, since agenda item no. 11 was approved, the complementary examination will get cancelled and in that process, complementary MSE also, will not be there. Repeat-MSE will help to improve the performance of regular MSE, if it is poor.)

This modification in Autonomy / Examination Rules will be applicable for all students of the institute studying in any year of study of the B. Tech. / M. Tech. program in the institute in A. Y. 2022-23 onwards.

Item No 16

To discuss and decide about the proposal for removing the provision of Re-valuation and Issue of Photocopy of Answer Book.

(Modification proposed in Examination Rule R 14)

Only revaluation of answer books will be done.

No Re-valuation and Issue of Photocopy of Answer Book is proposed.

Reasoning:

Current provision in revaluation: If change in marks is more than 20% in revaluation, then the third evaluator shall be appointed and marks assigned by that evaluator shall be the final marks. As per this existing rule under revaluation, provision of a third evaluator is already in place. Also, the time for declaration of final result and that between regular and re-examination can be reduced, resulting in more time for academics and other activities in the academic calendar. Considering these points, the proposal was approved in the meeting.

This modification in Examination Rule will be applicable for all students of the institute studying in any year of study of the B. Tech. / M. Tech. program in the institute in A. Y. 2022-23 onwards.

Item No 17

To discuss and decide about the proposal of simplifying the process of grant of Grace marks / Condonation to the students.

(Modification proposed in Autonomy Rule R 21.2)

Under the existing rule, the grace / condonation marks can be allotted to pass one or two courses at any examination, provided that the overall result of that examinee changes from FAIL to ATKT **OR** from ATKT to PASS. This condition may prevent the student from availing the benefit of this provision, if he has more than two backlog courses and out of that, if he finds some course very difficult to pass, even in further attempts.

In view of the above points, the proposal for the removal of the condition of “provided that the overall result of that examinee changes from FAIL to ATKT **OR** from ATKT to PASS” while allocating Grace / Condonation marks, was approved in the meeting. Other rules of Grace marks will remain the same.

This modification in Autonomy Rules will be applicable for all students of the institute studying in any year of study of the B. Tech. / M. Tech. program in the institute in A. Y. 2022-23 onwards.

Item No 18

Any other point/s by the permission of chair.

As per the directions of Hon. Chairman-AC, the Dean (Academics) provided information about reconstituting the Academic Council and also all the Boards of Studies, as per the revised guidelines for Autonomous Institutes issued by the UGC. The re-constitution of these academic bodies shall be done after the nominations on these academic bodies are received from the KBCNMU, Jalgaon.

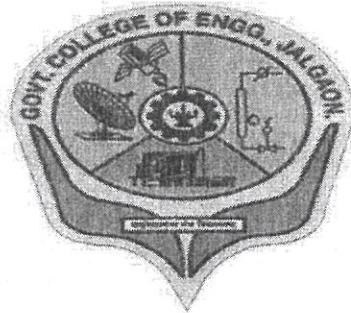

At the start of the meeting, Member Secretary-AC Dr. S. P. Mohani and Chairman-AC and Principal Dr. R. D. Kokate welcomed honorable members of Academic Council (AC). With the permission of chairman-AC, the proceedings of the AC meeting started.

The online AC meeting started with the welcome of all Hon. Members of AC by chairman and member secretary of Academic Council.

Item No 1:

To read and confirm the minutes of twelfth (12th) meeting of Academic Council held in the online mode on Tuesday, September 15; 2020 at 3.00 pm.

The twelfth (12th) meeting of Academic Council (AC) was held on 16th September, 2020 in online mode. The MoM of this meeting were already shared with all members. It was shared in online mode. (*Annexure 1*)

The MoM of the earlier (12th) meeting were confirmed by the AC.

Item No 2:

To note and approve the action taken by the institute on the agenda points discussed and resolved in the earlier meeting of Academic Council.

The Action Taken Report on the basis of MoM of AC-12 was shared and read in online mode. It was approved by AC. (*Annexure 2*)

Item No. 3:

To apprise the Hon. AC of various examinations held in online mode, student promotion policy implemented, the online exam software used, and concession in examination fee, in view of COVID-19 situation in 2019-20 and 2020-21

The document containing the details of various examinations held in online mode, student promotion policy implemented, the online exam software used, and concession in examination fee, in view of COVID-19 situation in 2019-20 and 2020-21, was shared to all members in online mode. (*Annexure 3*)

The AC noted and appreciated the efforts of all the Academic and Examination Cell (AEC) members and AEC staff in the conduction of all examinations continuously from October 2020 to till date.

All the points mentioned in the agenda point No. 3 were approved by AC.

Item No. 4:

To consider the applications of extension of one year for completing the degree program (in view of their certain circumstances also in view of COVID-19 situation) and provide the decision of AC.

An application of a student Mr. Sachin Devkamble is received for extension of one year for completing the degree program. He had submitted an application in December 2017 to the institute, that he has joined a Govt service due to financial situation of his family and that's why he would take an educational break. In Nov-2020, he applied for admission for remaining education (He is admitted provisionally to Sem.VI). He also submitted the document of a leave of 2 years from Govt. service to complete the remaining education. His admission year is 2016-17 as a DSY student. His 5 years are getting over by 2020-21 and requires an extension of one year for completing the degree program.

The application was shared with all members in online mode (*Annexure 4*) and the case was explained by member secretary - AC.

AC discussed and granted the extension of one year to this student for completing the degree program.

Item No. 5:

To discuss and approve the reduction in the requirement of Audit Points from 12 to 10 (also from 9 to 7 in case of DSY students and from 6 to 4 for M. Tech.) for eligibility for the award of degree (in case of both co-curricular and extra-curricular activities) in view of COVID-19 situation.

In view of Covid-19 situation, since the students were unable to complete the required number of co-curricular and extra-curricular activities in the final semester, it was proposed to reduce the audit point requirement for final year students of 2020-21 as follows:

- from 12 to 10, for regular admitted UG students, for co-curricular and extra-curricular activities each.
- from 09 to 07, for lateral entry (Direct Second Year admitted UG students), for co-curricular and extra-curricular activities each.
- For PG students from 12 to 10 for co-curricular activities, which shall include at least one paper with guide published in national/international conference or referred journal.

Also, it was proposed to accept online participation in any corresponding co-curricular and extra-curricular activities mentioned in the autonomy rules, for the purpose of allocation of audit points, for final year UG and PG students of 2020-21.

AC discussed and approved the above proposal.

Item No. 6

To grant approval for the revised Academic Calendar implemented for A. Y. 2020-21 (due to COVID-19 situation) and also discuss and approve proposed Academic Calendar for the upcoming A. Y. 2021-22

In view of COVID-19 situation, the academic calendar of AY 2020-21 had to be revised as per the situation and also according to the guidelines issued by UGC, State Govt. and KBCNMU, Jalgaon. In view of this, the revised academic and examination schedule conducted in AY 2020-21 was presented for approval by AC. (Annexure 5)

Also, the academic calendar for the upcoming academic year 2021-22 was presented to AC. (Annexure 6) These academic calendars for AY 2020-21 and 2021-22 were approved by the AC.

Item No 7:

To discuss and approve modifications (if any) in the curriculum structure and detailed revised syllabus of Fourth year (Final Year) of all B. Tech. Programs recommended by respective BoS.

The Final Year B. Tech. syllabus will be presented for all the six (6) B. Tech. programs in the following sequence:

1. Mechanical Engineering
2. Electronics and Telecommunication Engineering
3. Instrumentation Engineering

Existing Rule 7.1 and 7.2

R 7 Audit Point In addition to academic credits, student has to complete audit courses for obtaining audit points as given below.

R 7.1 Co-curricular Activity: Co-curricular Activity: A minimum 12 audit points for co-curricular activities shall be earned by the UG student during his course of study distributed over at least 4 semesters while PG student shall earn minimum 12 audit points for co-curricular activities/courses which shall include at least one paper with guide published in national/international conference or referred journal for PG students and one paper presented by the group in any state/national/international level technical paper presentation competition of UG students or in state/national/ international conference/journal. There is no limit on maximum audit points earned by the student. The final grade sheet will include the actual number of audit points earned by the student during the entire course of study. For lateral entry admission in UG (DSE or absorbed from university pattern etc), student shall obtain a minimum audit points at the rate of 3 audit points per year of study in autonomous pattern for co-curricular activities distributed over at least 3 semesters (2 in case of admission in final year).

R 7.2 Extra-curricular Activity: A minimum 12 audit points for extra - curricular activities shall be earned by the UG student during his course of study distributed over at least 4 semesters. There is no limit on maximum audit points obtained by the student. The final grade sheet will include the actual number of audit points obtained by the student during his entire course of study. For lateral entry admission in UG (direct admission to second year), student shall obtain a minimum audit points at the rate of 3 audit points per year of study in autonomous pattern for co-curricular activities distributed over at least 3 semesters (2 in case of admission in final year).

Modified Rule 7.1 and 7.2

R 7 Audit Point In addition to academic credits, student has to complete audit courses for obtaining audit points as given below.

R 7.1 Co-curricular Activity: Co-curricular Activity: A minimum **8 audit points for co-curricular activities (Essential: 8, Desirable: 12)** shall be earned by the

There is no limit on maximum audit points earned by the student. The final grade sheet will include the actual number of audit points earned by the student during the entire course of study. For lateral entry admission in UG (DSE or absorbed from university pattern etc), student shall obtain a minimum audit points at the rate of **2 audit points per year** of study in autonomous pattern for co-curricular activities distributed over at least 3 semesters (2 in case of admission in final year).

R 7.2 Extra-curricular Activity: A minimum **8 audit points for extra - curricular activities (Essential: 8, Desirable: 12)** shall be earned by the UG student during his course of study distributed over at least 4 semesters. There is no limit on maximum audit points obtained by the student. The final grade sheet will include the actual number of audit points obtained by the student during his entire course of study. For lateral entry admission in UG (direct admission to second year), student shall obtain a minimum audit points at the rate of **2 audit points per year** of study in autonomous pattern for co-curricular activities distributed over at least 3 semesters (2 in case of admission in final year).

Existing Rule R 15.4

There shall be five ESE in one academic year; out of which the first two ESE (viz winter and re-examination winter) shall be conducted only for all the courses of odd semester while next two ESE (summer and re-examination summer) shall be conducted only for all the courses of even semester and the fifth ESE (Complementary Examination) shall be conducted for all the theory courses of odd as well as even semester.

Modified Rule R 15.4

There shall be **four** ESE in one academic year; out of which the first two ESE (viz winter and re-examination winter) shall be conducted only for all the courses of odd semester while next two ESE (summer and re-examination summer) shall be conducted only for all the courses of even semester. ~~and the fifth ESE (Complementary Examination) shall be conducted for all the theory courses of odd as well as even semester.~~

Existing Autonomy Rule R 15.5

R 15.5 It is mandatory to secure at least 40 % of maximum marks in total and at least 1/3rd of maximum marks assigned to ESE of that course in ESE to pass the course. It implies, any student securing more than 40 % marks in total in any course but less than 1/3rd of maximum marks assigned for ESE of that course in ESE shall be declared as fail (F grade).

Modified Rule R 15.5

R 15.5 It is mandatory to secure at least 40 % of maximum marks in total and at least 30 % of maximum marks assigned to ESE of that course in ESE to pass the course. It implies, any student securing more than 40 % marks in total in any course but less than 30 % of maximum marks assigned for ESE of that course in ESE shall be declared as fail (F grade).

Existing Examination Rule R14

14. Re-valuation and Issue of Photocopy of Answer Book: The candidate who has applied for revaluation shall be entitled to apply for a combined process of re-valuation and issue of photocopy of his/her assessed answer books of end semester theory examination(s) in which he/she has appeared. The aspiring candidate shall apply to AEC office in prescribed format by paying requisite fees as per following procedure and obtain the acknowledgement.

Decision of AC:

Removal of this provision is approved by AC.

Existing Rule R 21.2

Grace marks to pass the course: The examinee shall be given benefit of grace marks only for passing in any head of passing as shown in table 9; provided that the overall result of that semester/year of that examinee changes from fail to ATKT or from ATKT to Pass at that examination. The examinee can avail this facility for maximum two courses at any examination.
